Submit an email to TRACEN Yorktown Special Security Officers via <a href="mailto:TCY-DG-SSO@uscg.mil">TCY-DG-SSO@uscg.mil</a>. SUBJ line: Request to commence the IS “A” School pre-screening process. In the body of the email, provide your name, unit, the Command Supervisor and Command Security Officer (CSO) contact information. If you are an E-2, include the start date at your first unit</p></div>	<p><b><u>IS Application Process Continued</u></b></p> <p>2. The pre-screening process is the exchange of forms/documentation via email, which can usually be completed within a few weeks. If the pre-screening results are favorable, the TCY SSO will provide the member and their Command/CSO, a SSO worksheet. The applicant will initiate the first step in the A-School request process via Direct Access (DA). Member’s Command will approve the IS “A” School request in DA and include the SSO worksheet as an attachment to the DA submission. Once approved, EPM-2 will notify member/Command, the applicant’s name was formally added to the IS waitlist. Members <b><u>WILL NOT</u></b> be added to the IS “A” School waitlist without the SSO worksheet.</p> <p>3. Members are added to the IS “A” School waitlist according to the signature date on the A-School request form. The A-School request form cannot be dated prior to the approval date on the SSO worksheet. Failure to comply will result in the request being rejected and returned.</p> <p>4. Upon notification from EPM-2, the applicant has been added to the IS “A” School waitlist, the member can begin the Tier 5 (Top Secret) investigation. Upon receipt, forward the EPM-2 notification to <a href="mailto:TCY-DG-SSO@uscg.mil">TCY-DG-SSO@uscg.mil</a>. The TCY SSO will initiate the Tier 5 investigation. The unit CSO will facilitate the fingerprints, CG-5588, SF-312, and all tasks that cannot be completed by the TCY SSO. The unit CSO SHALL NOT request Sensitive Compartmented Information (SCI) eligibility for the member. That portion of the clearance will be requested by the TCY SSO.
